



Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to Somerset County Democratic Committee Black Caucus General Membership (“SCDC Black Caucus”), and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to SCDC Black Caucus include SCDCBlackCaucus.org and SCDC Black Caucus and SCDCBC. The SCDC Black Caucus membership is available to all of the persons wishing to joining the SCDC Black Caucus Organization. By completing the SCDC Black Caucus application for general membership, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, SCDC Black Caucus may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

When you purchase a SCDC Black Caucus membership on line, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us.

Use of your Personal Information

SCDC Black Caucus collects and uses your personal information only to operate and deliver the services you have requested.

Sharing Information with Third Parties

SCDC Black Caucus does not sell, rent, lease or give its membership lists to third parties.

Upon your approval SCDC Black Caucus may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to SCDC Black Caucus, and they are required to maintain the confidentiality of your information.

SCDC Black Caucus may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on SCDC Black Caucus or the site; (b) protect and defend the rights or property of SCDC Black Caucus; and/or (c) act under exigent circumstances to protect the personal safety of users of SCDC Black Caucus, or the public.

Right to Deletion

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Delete your personal information from our records; and



- Direct any service providers to delete your personal information from their records.

Please note that we may not be able to comply with requests to delete your personal information if it is necessary to:

- Complete the transaction for which the personal information was collected,
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Comply with an existing legal obligation.

Children Under Thirteen

SCDC Black Caucus does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this application.

E-mail Communications

From time to time, SCDC Black Caucus may contact you via email for the purpose of providing announcements, alerts, confirmations, surveys, and/or other general communication. In order to improve our Services, we may receive a notification when you open an email from SCDC Black Caucus or click on a link therein.

External Data Storage Sites

We may store your data on servers provided by third party hosting vendors with whom we have contracted.

Changes to this Statement

SCDC Black Caucus reserves the right to change this Privacy Policy from time to time. We will notify you about significant changes in the way we treat personal information by sending a notice to the primary email address specified in your application, by placing a prominent notice on our application, and/or by updating any privacy information. Your continued use of the application and/or Services available after such modifications will constitute your: (a) acknowledgment of the modified Privacy Policy; and (b) agreement to abide and be bound by that Policy.
